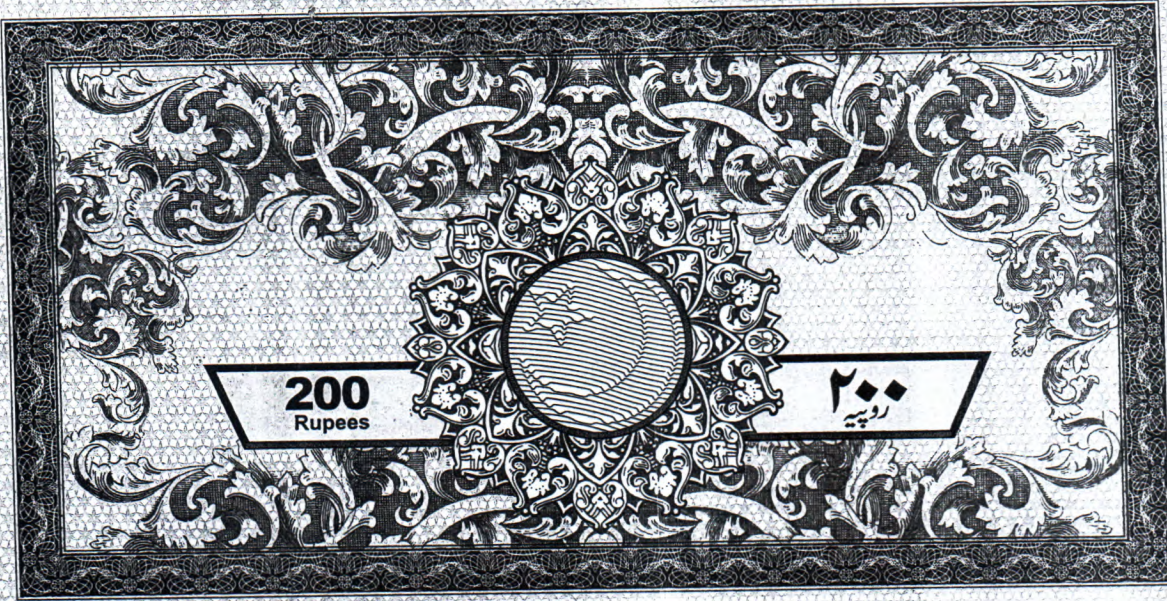

ADDENDUM

This Addendum ("Addendum") is made at Karachi on 15th September 2025

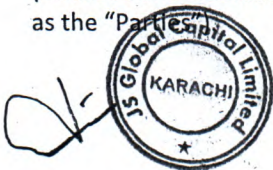
By and between

JS Global Capital Limited, a company incorporated under the laws of Pakistan, having its registered office at 16th Floor, The Centre, Abdullah Haroon Road, Karachi, Pakistan (hereinafter referred to as the "Licensee"),

And

Microlinks Private Limited, a company incorporated under the laws of Pakistan, having its registered office at Office No. 404, Business Forum, MSGB Society, Khalid Bin Waleed Road, Karachi, Pakistan (hereinafter referred to as the "Licensor").

(Licensee and Licensor shall hereinafter be referred to individually as a "Party" and collectively as the "Parties")



WHEREAS

- The Parties have previously entered into a Software License and Support Agreement dated 17th March 2022 ("Agreement").
- The Parties now wish to amend and record certain mutually agreed financial terms and deliverables through this Addendum.

NOW, THEREFORE, it is hereby agreed as follows:

1. Development Cost

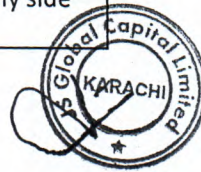
- Development cost of SEAMS Backoffice Oracle Upgrade, RAAST CDC Aggregator Module for Payment Collection and payment withdrawal is [REDACTED] Taxes
- The above amount shall be settled in two (2) installments:
 - PKR [REDACTED] - + Taxes upon confirmation.
 - PKR [REDACTED] - + Taxes on or before **31st January 2026**.

2. Monthly Support Charges

- For the period July 2025 to September 2025, the bill will be payable at the current existing value of PKR [REDACTED] - + taxes.
- PKR [REDACTED] - + Taxes per month, payable in advance, from October 2025 to June 2026.
- From July 1, 2026 onwards, an annual minimum **10%** increment in AMC will be applicable.




Other Terms
